Na základe avizovaného zvyšovania cien od našich dodávateľov, budeme nútení premietnuť toto zvýšenie aj do našich predajných cien. Hlavným dôvodom cenového navýšenia sú neustále sa zvyšujúce náklady na výrobu, balenie a prepravu papiera. Zvýšenie bude realizované **od 2.1.2024** podľa závozov na sklad.

Zároveň by sme Vás chceli informovať, že od 1.1.2024 sa zvyšuje aj odvod do recyklačného fondu o 34 €/tona, t.j. na výšku 109 €/tona papiera.

Burgo Group will increase prices for all its WFC range (sheets and reels) by at least 7%.

New conditions will be applied on all markets starting from January deliveries.

This announcement follows previous communication related to all uncoated grades (sheets, reels, copy, ink jet) and it is a necessary step considering negative trend of raw material costs which are expected to have a continuous growth with a heavy impact on profitability.

Effective with orders shipping December 1st, 2023, onwards Navigator will increase the price of all our Uncoated Woodfree Papers by 5-7% in Europe.

The price adjustment is necessary due to the structurally higher price of most input costs essential for paper manufacturing, that makes current price levels unsustainable. Additionally, and more recently, pulp and energy have experienced significant increases. The recovery in demand visible in the global markets also contributes to this price adjustment.
